WHEREAS; physical therapists, assistants, and students have clinical expertise in 18 specialty areas, namely acute care, aquatics, cardiovascular and pulmonary, clinical electrophysiology and wound management, education, federal, geriatrics, hand and upper extremity, health policy and administration, home health, neurology, oncology, orthopedics, pediatrics, pelvic health, private practice, research, and sports; and

WHEREAS; as we continue to collectively face the unprecedented challenges of the COVID-19 pandemic, our state's physical therapists, assistants, and students continue to be instrumental in treating people who are recovering from the most severe effects of the virus, both during their time in the hospital and after they leave; and

WHEREAS; in 2020, the American Physical Therapy Association (APTA)—which is the leading professional membership organization for the profession—launched its Campaign for Future Generations to advance diversity, equity, and inclusion efforts for the association and throughout the physical therapy profession; and

WHEREAS; this month, as we celebrate the 100th anniversary of APTA, the state of Wisconsin joins all Wisconsinites in thanking the physical therapists, assistants, and students working every day to keep folks across our state healthy, active, independent, and pain-free;
